## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Beacon Hill Water and Sewer District from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Cash receipting
- Safeguarding of inventory
- Disbursements
- Software conversion
- Open public meeting minutes

### **Financial**

That report includes a finding for a material weakness in internal controls over financial reporting regarding the District's calculation of its investment in associated organization.

## INFORMATION ABOUT THE DISTRICT

The Beacon Hill Sewer District was formed in 1959 to provide wastewater collection and transmission for the Beacon Hill and Columbia Heights areas of Longview and Kelso. Lexington area customers were added to the system in the early 1970s. On December 28, 2010, the District acquired the water system from Cowlitz County Public Utility District No. 1 and now serves approximately 4,000 customers.

An elected, three-member Board of Commissioners governs the District. Board Members serve staggered, six-year terms. The Board appoints a District Manager to oversee the District's daily operations as well as its 10 employees. For 2014 and 2015, the District operated on annual budgets of approximately \$4 million.
